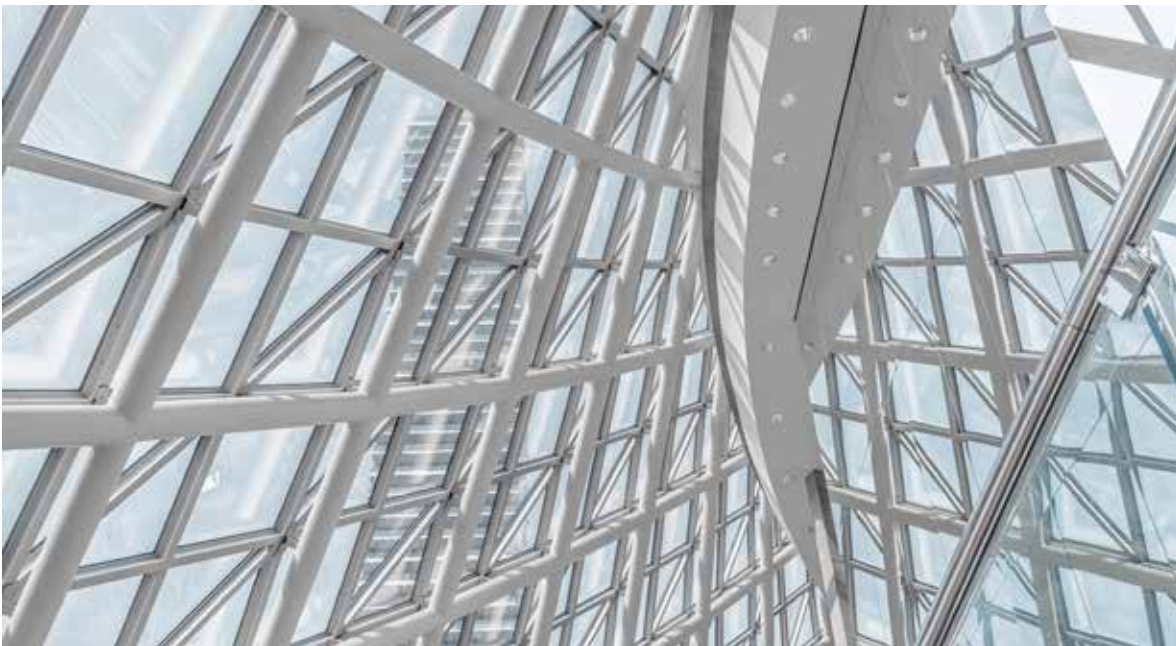
Commercial Services

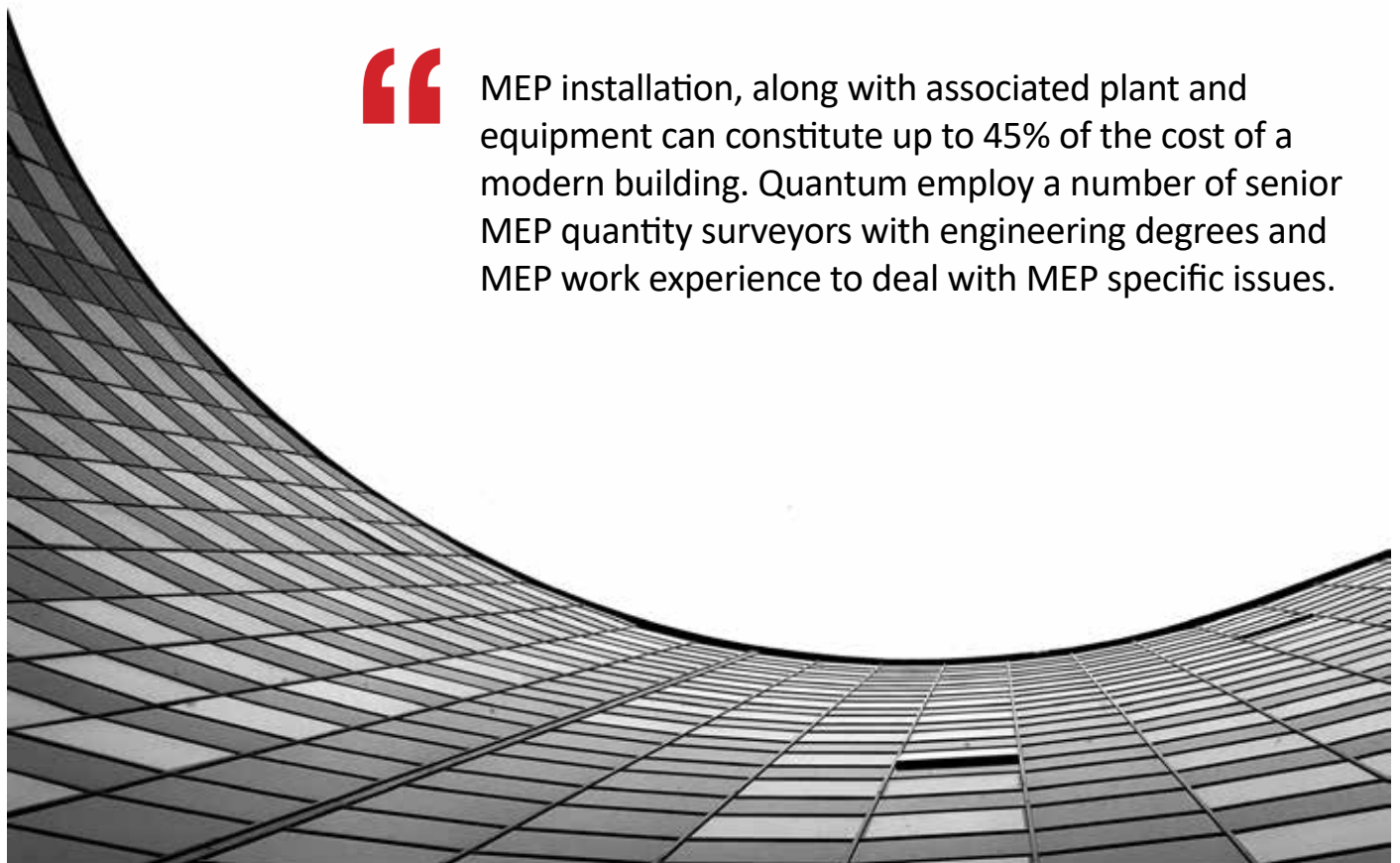

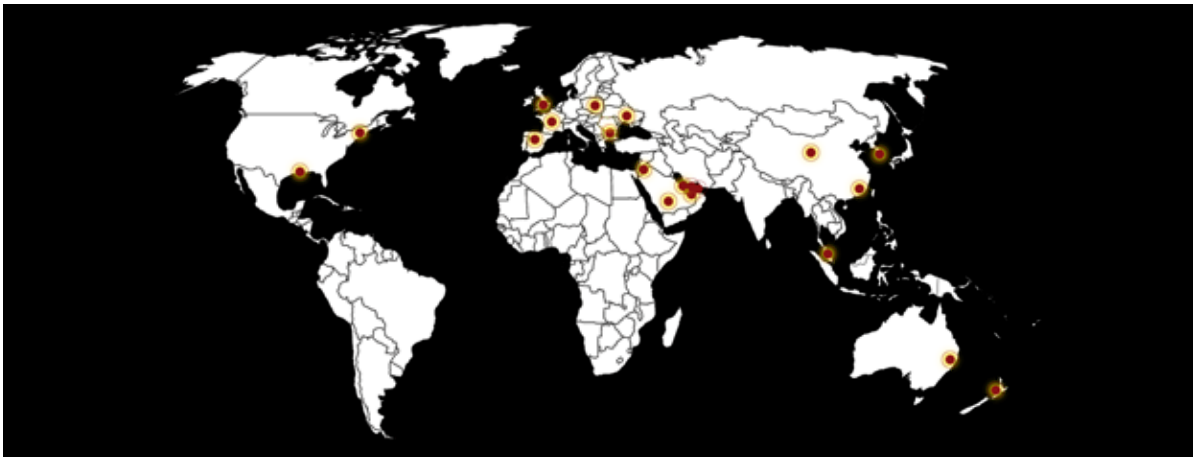
